ASSIGNMENT OF CERTIFICATES OF MEMBERSHIP IN POLNELL LANDING WATER ASSOCIATION

CERTIFICATES OF MEMBERSHIP in the Polnell Landing Water Association are hereby assigned and transferred to Lots 1-16 of Cheleek PRD as follows:

Recitals

- 1. The Polnell Landing Water Association (also, the "Association"), a Washington non-profit corporation located in Oak Harbor, Washington, operates a water system that has been approved by the Washington State Department of Health to serve 27 (twenty seven) domestic connections under Department of Health Identification Number 55476W.
- 2. The By-Laws of the Polnell Landing Water Association ("By-Laws") (Island County Auditor's File No. 86015123) provide for water supply and ownership interests in the Association and its water system to be transferred through certificates of membership to the Association. Each certificate of membership entitles the certificate owner to one water service to the Association, which shall be and remain appurtenant to the specific parcel for which the membership is granted. The By-Laws further transferred to Robert S. Roberts, its then current President, all existing certificates of membership for his sale and distribution.
- 3. By an Agreement for Assignment of 25 Certificates of Membership in Polnell Landing Water Association, (etc.) (referred to as "Agreement for Assignment") (Island County Auditor's File No. 93014781), Robert S. Robert conveyed and assigned to Terry Mitchell and his mother, Norma R. Mitchell 25 (twenty five) certificates of membership in the Polnell Landing Water Association to be appurtenant to certain lands designated within the Agreement for Assignment as the Mitchell Real Property.
- 4. Norma R. Mitchell transferred her interest in the 25 (twenty five) certificates of membership in the Polnell Landing Water Association to the Norma R. Mitchell Trust, under that trust December 5, 1987, of which Terry Mitchell, Marsha Cook, and Robin Bridges are co-trustees.
- 5. On or about August 18, 2003 the above-referenced Mitchell Real Property was platted into the Cheleek Planned Residential Development, volume 1
 - pages 124-29 of Planned Residential Development recorded under Island County Auditor's File Number 4071107.

- 6. The By-Laws provide for certificates of membership to be issued to individual, subdivided parcels within the Mitchell Real Property.
- 7. Prior to this assignment, the Polnell Landing Water Association had assigned nine (9) certificates of membership to the Association to parcels outside of the Mitchell Real Property. Those nine assignments of certificates of membership are not among the 25 certificates assigned within the Agreement for Assignment referenced in paragraph 3 of these recitals.
- 8. Prior to this assignment, assignments of certificates of membership have been made to properties that have become Lots 2, 3 and 4 within the Cheleek PRD. The assignments of certificates of membership to those Lots 2, 3 and 4 within this assignment instrument are without prejudice to whatever rights may have accrued by prior assignments to Lots 2, 3 and 4.

The owners of the above described real property are required to comply with all of the terms and conditions of the said Articles of Incorporation and By-Laws, including but not limited to, the payment of dues and assessments and the enforcement of the same by lien rights and foreclosure in the event of failure to pay the said dues and assessments.
- 19. This assignment is of certificates of membership in the Polnell Landing Water Association and not an assignment of water rights. In making this assignment, the grantors and assignors, Terry L. Mitchell, Marsha Cook, and Robin Bridges, neither individually nor as co-trustee of the Norma R. Mitchell Trust, dated December 5, 1987, nor as Board members of the Cheleek Community Association make any representation, warranty, assurance, or guarantee as to the service, condition, capacity, or operation of the Polnell Landing Water Association, the nature, extent or validity of water rights or the water purveyor approvals held Polnell Landing Water Association, or of the quality, quantity, condition availability of water or water service from the association and do not indemnify the assignees of the certificates of membership regarding these matters.
